

## APPEARANCE RELEASE

I further agree that Producer may use and license others to use my name, voice, likeness and any other biographical material concerning me which I may provide for promotion, advertising, sale, and publicizing of the Program and in connection with Producer's, Distributor's and/or their Affiliated Companies' production and distribution of the Program, throughout the world, in all media (now known or hereafter devised), an unlimited number of times, in perpetuity. I further represent that any statements made by me during my Appearance are true, to the best of my knowledge, and that neither my Appearance nor any statements made by me will violate or infringe upon the rights of any third party.

I hereby waive any right of inspection or approval of my Appearance or the uses to which such Appearance may be put. I acknowledge that Producer will rely on this permission, potentially at substantial cost to Producer, and hereby agree not to assert any claim of any nature whatsoever (including any claims for injunctive relief and/or money damages) against anyone relating to the exercise of this permission granted hereunder.

I agree not to issue any press releases or other public statements, including but not limited to, speaking to the press about my involvement or regarding Producer's, Distributor's and/or their Affiliated Companies' involvement in the Program without Producer's, Distributor's and/or their Affiliated Companies' (as applicable) prior written permission. I agree not to use Producer's, Distributor's or their Affiliated Companies' name, logo, trademark or other proprietary mark in any manner without Producer's, Distributor's or their Affiliated Companies' (as applicable) prior written approval in each instance.
