INVESTIGATIVE NARRATIVE

On 4-27-08, at approximately 0127, Oxford Life Squad was dispatched to 111 E. Spring Street for a male who had fallen from his bed and suffered a head injury. When I arrived I was led to the back bedroom on the first floor and found the male, later identified as Aaron Patrick Miller, laying on his right side bleeding from either his nose or mouth. Miller was unconscious but was breathing at the time, with his face starting to turn blue. Oxford Life Squad was on scene approximately 45 seconds to a minute after I arrived.

After retrieving the backboard and gurney from the squad I returned to the room when I heard someone state they thought he may have stopped breathing. He was secured on the backboard and transported to McHyde for treatment.

At the hospital I spoke with Miller's girlfriend, Hollie C Burge. She stated that Miller had not been feeling well so they went to bed early. She stated that he was laying on the edge of the bed that was about 6 feet off the ground. About 45 minutes after they laid down she stated Miller rolled over and fell of the bed onto the floor. She stated that she called for him and asked if he was ok. He did not respond and she her him gasping for air. She immediately got out of bed and found Eric McNeily who was standing in the hallway outside of the bedroom who in turn called for police.
