SUBJECT: IC IG Forum Update on Review of the Boston
Marathon Bombings

Under the IC IG's authorities as chairman of the statutory IC IG Forum, the IC Inspector General, the Central Intelligence Agency Inspector General, the Department of Justice Inspector General, and the Department of Homeland Security Deputy Inspector General have been conducting a coordinated review into the U.S. Government's handling of intelligence information leading up to the Boston Marathon bombings on April 15, 2013. The Inspectors General have been working diligently toward completing this review; however, information relevant to the review is still being provided to the review teams. When all requested information has been received and analyzed, we will be able to provide a better estimate of the timeframe for producing a draft report.


